SSDP directly trained hundreds of students in grassroots skills-building programs on topics such as organizing, leadership, public speaking, community education, fundraising, and advocacy. We educated students on drug policies including those related to changing marijuana and other drug prohibition policies to be more sensible and less punitive, promoting harm reduction/overdose prevention practices, providing evidence-based drug education, and teaching students about international drug policy, racial justice, civil rights, human rights and their constitutional rights. The national staff organized six regional conferences on similar topics for more than 300 students and facilitated attendance at the Drug Policy Alliance's Reform conference for more than 60 students.
